Sub: Amendment to the Cadre and Recruitment Rules for the Post Of Director, Medical Superintendent and Teaching Faculty

- - -

Whereas in the meeting of all the Principals of Medical Colleges conveyed by Registrar of RGUHS in its letter dated 4.5.2001 decided to adopt MCI Regulations for minimum qualifications for teachers in medical institutions.

02. Whereas the Governing Council of KMIO at its meeting held on 25.1.2002 had approved in principle the adoption of Medical Council of India Regulations.

03. Whereas, Medical Council of India guidelines Teachers Eligibility Qualifications, 1998 (Summary) has provided for minimum educational qualification for the teachers in Medical Institutions for the post of Director, Medical Superintendent, Professor, Associate Professor and Assistant Professor/Lecturer for Specialities and super specialities. The Government of India has accorded the status of Regional Cancer Centre to Kidwai Memorial Institute of Oncology. The Indian Council of Medical Research has recognised this as Referral Institution and as research Association. The decade from 1980-90 has changed the face of the Non-descript cancer hospital to a well known major and a model, comprehensive regional centre for cancer research, teaching (under graduate and post graduate, Super speciality courses) and sophisticated diagnostic and treatment services. The patients not only come from Karnataka but also from neighbouring states of Tamilnadu, Kerala and Maharashtra.

04. Whereas this Institute has also been accorded the status of Institute for excellence and recognised as a training centre for WHO fellowship. Keeping in view the requirements of the Institute for its excellence, it is proposed to amend the Kidwai Memorial Institute of Oncology Cadre and Recruitment Rules.

05. In exercise of the powers conferred by the provision 10 of the rules and Regulations of the KMIO, the Governing Council in its Special General meeting dt: 9.5.2006 has approved the following rules, namely ;

01.Short Title and Commencement :

02.These rules may be called the Kidwai Memorial Institute of Oncology (Cadre and Recruitment) Rules 2006.

03.They shall come into force with immediate effect.
